Project Title: Timber Harvest Plan "Phoenix" 1-24-00054-SCR (Streambed Alteration Agreement No. EPIMS-SCR-52884-R3)

Project Location (include county): The Phoenix Timber Harvest Plan (THP) is situated within the 8,852-acre San Vicente Redwoods property, Santa Cruz County, U.S. Geological Survey (USGS) Davenport map, Rancho San Vicente Section, Township 9S and 10S, Range 3W, Mount Diablo base and meridian.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number EPIMS-SCR-52884-R3 pursuant to section 1602 of the Fish and Game Code to the project applicant, Nadia Hamey.

The project is limited to replacement of 20 culverts, replacement of one culvert with a rocked ford, removal of two culverts, installation of two new culverts, water drafting from Filice Pond, and Accelerated Wood Recruitment (AWR) in Upper Big Creek as denoted in the approved 1- 24-00054-SCR "Phoenix" THP.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on June 11, 2025 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will / will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Timber Harvest Plan prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
