NOTICE OF EXEMPTION

Project Title: James Bypass Basins and Recharge Project (Notification of Lake or Streambed Alteration, No. EPIMS-FRE-45038-R4)

Project Location (Fresno): The Project will occur at James Bypass in southwest Madera County approximately 10 miles south of the City of Kerman; Section 34, Township 15 South, Range 17 East; USGS 7.5 Minute Quad Map Helm MDB&M; Assessor’s Parcel Number 030-12-16ST; Latitude 36.581992, Longitude -120.105963.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement Notification No. EPIMS-FRE-45038-R4, pursuant to Section 1602 of the Fish and Game Code, to the James Irrigation District.

Project activities will include the construction and operation of a new check structure on the eastern auxiliary channel of the James Bypass in support of future groundwater recharge, by pooling water within the auxiliary channel for recharge, and increasing the water elevation to allow for the increased diversion of flood flows from the auxiliary channel into an existing adjacent groundwater recharge basin.

Exempt Status:

- Statutory Exemption.
- Categorical Exemption.

Reasons why project is exempt: CDFW’s issuance of an Agreement is generally subject to CEQA (Pub. Resources Code, § 21000 et seq.) and its implementing regulations; however, CEQA is suspended per Executive Order N-7-22 (EO) for purposes of CDFW’s issuance of this Agreement. Paragraph 13 of the EO states that CEQA and its implementing regulations are suspended for the following, to the extent necessary to address the impacts of drought: (1) specified actions taken by state



agencies and specified actions taken by a local agency where the Department of Water Resources concurs that local action is required; and (2) any permits necessary to carry out actions under (1). Actions under (1) are recharge projects under either Flood-Managed Aquifer Recharge or the Department of Water Resources Sustainable Groundwater Management Grant Program occurring on open and working lands to replenish and store water in groundwater basins that will help mitigate groundwater conditions impacted by drought. Because the Project to which this Agreement applies involves construction of facilities for subsequent diversions of flood flows for application to open and working lands to replenish and store water in groundwater basins to help mitigate groundwater conditions impacted by drought, no environmental review for this Agreement pursuant to CEQA is required at this point in time. Consequently, CDFW has not reviewed a certified environmental impact report or adopted mitigated negative declaration evaluating this project, nor has CDFW adopted related findings pursuant to CEQA. Similarly, in applying for this permit, Permittee relied on the CEQA suspension provided by Paragraph 13 of the EO.
