The Project is intended to provide bank stabilization at two locations along the Guadalupe River upstream of Malone Road and Almaden Road and at Blossom Hill Road between Sanchez Drive and Blossom Hill Drive. Along these sections of the Guadalupe River, in-stream structures have significant erosion, and restoration of those embankments are needed to avoid risk of impacting neighboring properties.
