Caltrans proposes to repair the I-8 Eastbound and Westbound Pine Valley Creek Bridge (57- 0692 L/R) in San Diego County. Project work consists of removing the entire existing 1" polyester concrete overlay that is delaminating and failing by removing the existing surface treatment (Rt Bridge = 6,793 SQ FT) (Lt Bridge = 6,598 SQ FT), repairing the approach and departure slabs, replacing joint seals, and placing new traffic striping.
