Project Location: The Project is located at 1000 SAINT FRANCIS WAY, SUITE A, RIO VISTA, CA 94571, in Solano County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Microbusiness License submitted on 12/26/2017 by GEORGE 7280 LLC.

Project Activities:

The proposed project will operate a microbusiness license out of an existing facility located at 1000 SAINT FRANCIS WAY, SUITE A, RIO VISTA, CA 94571 (APN 0178-230-020). The applicant will store cannabis products for retail, distribution, and type 6 manufacturing (water and mechanical extractions) in 4,300 square foot facility. The project will receive water from the City of Rio Vista and energy from PG&E. The project is located on 1.24 acres within Rio Vista. The site is substantially surrounded by urban uses with no value as habitat for endangered, rare or threatened species. The project will not have any significant impacts to traffic, noise, air quality, or water quality.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 Categorical Exemptions consist of being consistent with the City's General Plan and Zoning Code, located within the city limits, project is no more than five acres, substantially surrounded by urban uses, no value as habitat for endangered, rare, or threatened species, no result in any significant effects relating to traffic, noise, air quality, or water quality, and is adequately served by all public utilities. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
