Caltrans proposes a pavement replacement project on the I-8 both EB and WB from Harbison Canyon Road to Willows Road in San Diego County. Work consists of repairing failed roadway structural pavement section in heavy truck lanes by grinding 0.2 ft of the RHMA on the existing roadway, replacing it by paving and filling the removed sections with new asphalt concrete, and striping. Repairs will be done for the full length of both EB and WB within project scope.
