Caltrans proposes a Culvert Repair Project in San Diego County on I-5 at various locations from 0.1 Miles South of Sampson Street Overcrossing to 0.1 Miles North of First Ave Overcrossing. Project work consists of repairing 5 culverts via Cured-in-Place-Pipe Liner (CIPP) by inserting a flexible liner into the upstream culvert end treatment which is then pulled through to the downstream culvert end treatment. Liner will be inflated and cured to harden. All environmental commitments are included in the Environmental Commitments Record (ECR).
