Description of Nature, Purpose, and Beneficiaries of Project:

The Project involves the renovation of the track and field located on the existing campus of New Brighton Middle School ("Middle School") in the City of Capitola in the County of Santa Cruz. Specifically, the Project consists of the conversion of the existing grass field to an artificial turf surface and the installation of a track and scoreboard. Related site work, minor grading, landscaping, utilities and related improvements are also part of the Project scope. The Project does not contemplate any new uses of the Middle School. This Project will provide enhanced safety conditions and accessibility for users of the field and will generally benefit District students and the local community. The Middle School campus and field will have substantially the same purpose and capacity upon the completion of the Project.
