Project Description

The California Department of Transportation (Caltrans) initiated a Director's Order for the purpose of repairing damage to the existing East 20th Street Overcrossing (OC) bridge that was hit by a high-load truck travelling in the northbound direction of State Route 99 on April 17, 2025. This project is needed to restore the load carrying capacity of the bridge located on State Route 99 at post mile (PM) 31.49 in Butte County. Caltrans proposes mobilization, repair/replace bridge girders, traffic control, and incidental work.
