The applicant proposes to construct a new, 100 percent affordable (30-60% AMI), 228-unit apartment complex in the Commercial Planned Development (CPD) zone. The project includes 24 one-bedroom units, 120 two-bedroom units, and 84 three-bedroom units. The project also proposes amenities associated with the apartments including a pool, community building, children's playgrounds, outdoor picnic areas, and basketball court.
