<p>The California Department of Transportation (Caltrans) issued a Director’s Order for the purpose removing structurally deficient eucalyptus trees and to replace damaged fencing on State Route 70 from post mile (PM) R8.29 to PM 13.60 in Yuba County. This project is needed to mitigate the potential for damaged tree limbs from falling into the roadway, creating a serious health and safety hazard for travelers. Caltrans proposes mobilization, remove damaged/structurally weak/dying trees, remove fallen branches, stump grinding, tree disposal, remove damaged fence, installation of new fence, and incidental work.</p>


