<u>Project Description</u>	
The California Department of Transportation (Caltrans) initiated a District Director's Order for an Emergency Force Account project with the purpose of removing rockfall debris and stabilizing the source slope adjacent to State Route 49 in Sierra County at post mile (PM) 1.96. This project is needed to mitigate the potential for future rockfall into the roadway which would create a safety concern for travelers. Proposed scope of work includes mobilization, rockfall mitigation, slope stabilization, debris removal, traffic control, and incidental work.
