Description of Nature, Purpose, and Beneficiaries of Project:

The purpose of the project is to repair structural deficiencies and address bank erosion and scour along Big Chico Creek in the City of Chico. Without the repairs, the structural integrity of the Rose Avenue bridge may be threatened and lead to the closure of the bridge.

The City of Chico Public Works Department proposes to repair the erosion on both banks and the scour around the piers, north abutment footing, and the sewer pipe using rock slope protection (RSP). RSP will also be used to reinforce the existing creek banks, the northeast abutment footing and wingwall, and a concrete-encased sewer pipe. The RSP will be underlain with a gravel filter.
