Contracted crew(s) will cut and chip shrubs and small trees, prune tree branches, apply herbicide, rake and relocate/remove vegetative debris, and apply other treatments as necessary to reduce hazardous fuels. In addition, at least 25 hazard trees will be felled and bucked or chipped.
