The project sites are in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District

Allow a solid waste processing facility, consisting of four (4) Biofiltro wastewater processing beds, one (1) lift station, one (1) mechanical separator, one (1) weeping wall, and one (1) concrete wall to split an existing settling cell into two cells on an 159.68-acre parcel for an existing pre-October 23, 2007 dairy located within the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District.

9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The project site is located on an established dairy. Surrounding area is agricultural land.

10. Other public agencies whose approval is required (e.g., permits, financing approval, or participation agreement.)

11. Have California Native American tribes traditionally and culturally affiliated with the project area requested consultation pursuant to Public Resources Code Section 21080.3.1? Per Assembly Bill 52 (AB52), participating California Native American Tribes, which had previously requested notification of land use projects were notified of the project and given the opportunity to enter consultation with the County regarding the proposal pursuant to Public Resources Code Section 21080.3.1; Of the four tribes that were notified, (Dumna Wo Wah, Picayune Rancheria of the Chuckchansi Indians, Santa Rosa Rancheria Tachi Yokut Tribe, and Table Mountain Rancheria), none responded to the notice or requested consultation.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code Section 21080.3.2.)

Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code Section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code Section 21082.3(c) contains provisions specific to confidentiality.
