Project Title: Phong Lee (Project)

Project Location: The Project is located at 441 North Vista Lane. Hayfork, CA 96052 (APN: 014-420-73-00) in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a small outdoor commercial cannabis license.

Project Activities: The Project will consist of 10,000 square feet (SF) of outdoor mature canopy and approximately 120 SF of immature canopy. Existing support infrastructure includes a 10'x12' shed for ag chemical storage, a 20'x24.5' garage for processing, packaging, and harvest storage; a 10'x12' shed for immature plants, a municipal water service connection, and a 100-gallon nutrient mixing tank. Power for the project is provided by TPUD and there is a permitted septic system onsite to serve the project's wastewater needs.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
