Project Location

Broadway Street from Wayland Lane to Hannah Street and Sargent Street from Broadway to First Street.

Detailed Project Description

On Broadway Street, approximately 370 feet of existing six-inch water pipeline would be removed, and the rest abandoned. Approximately 1,300 feet of new eight-inch ductile iron pipeline would be installed in the public right-of-way between Wayland Lane and Hanna Street using open trench methods.

On Sargent Street, the existing four-inch water pipeline would be abandoned in place, and approximately 210 feet of new eight-inch ductile iron pipeline would be installed in the public right-of-way between Broadway Street and First Street using open trench methods.
