Detailed Project Description

On Murray Avenue, the existing four-inch water pipeline would be abandoned in place, and approximately 70 feet of eight-inch ductile iron pipeline would be installed in the public right-of-way at the intersection of Murray Avenue and Burke Drive to reconnect the Burke Drive distribution main to the existing 12-inch pipeline on Murray Avenue. Twelve service lines along Murray Avenue between Burke Drive and Leavesley Road would be disconnected from the existing four-inch water pipeline and reconnected to the existing 12-inch water pipeline using open-cut methods.
