**Project Description**

The California Department of Transportation (Caltrans) proposes culvert replacement at Post Mile (PM) 7.28, on State Route (SR) 49 in Amador County. The scope of work includes replacing the existing 24"-diameter High Density Polyethylene pipe (Culvert ID No. 003-002) with a 24" Reinforced Concrete Pipe. All work will occur in Caltrans existing Right of Way. The purpose of the project is to address the deteriorated drainage system. The project is needed to prevent potential failure of the overlying highway due to the culvert deterioration and improve drainage.

#### **General:**

- Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact the Environmental Office if project changes occur or sensitive resources discovered.
- Contact the Environmental Office to attend the pre-construction meeting.

#### **Cultural:**

- If cultural materials are discovered at the job site, do not disturb the resources and immediately:
  1. Stop all work within a 60-foot radius of discovery
  2. Protect the discovery area
  3. Notify the Engineer
  4. The Department Investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

#### **Hazardous Waste:**

- The Caltrans Standard Special Provision 7-1.02K(6)(j)(iii), which pertains to Earth Material Containing Lead, shall be added to the construction contract. A Lead Compliance Plan prepared by a Certified Industrial Hygienist (CIH) is required and all soil must remain onsite.

#### **Biology:**

Include Caltrans Standard Special Provision 14-6.03A in the construction contract. If work occurs during the migratory bird nesting season (February 1 – September 30), preconstruction surveys must be conducted by a qualified Caltrans biologist within 14 days prior to the start of any construction activities. If active nests are observed, buffers will need to be established around each nest until the young have fledged, per California Department of Fish and Wildlife (CDFW) guidelines. A 100-foot buffer will be established around active nests. For hawks, a 300-foot buffer will be established. For Swainson's hawks, a 600-foot buffer will be established. If construction activities do not commence within 14 days of the cleared survey, or if construction activities stop for

more than 14 days, a subsequent bird survey may be required before construction commences or recommences. No construction activities shall commence without clearance from the Caltrans District 10 Environmental Office.
