Project Location: The Project is located at 1300 N Carpenter Road, Suite E and F, Modesto, CA 95351, in Stanislaus County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 5/30/2025, by Marlowe Mercado. McHenry Business Services LLC applied for a Microbusiness License in an existing facility.

Project Activities:

The Proposed Project will operate a Microbusiness license within an existing building at 1300 N Carpenter Road, Suite E and F, Modesto, CA 95351 (APN 029-050-008-000). The Project will conduct Type N Infusion manufacturing, storefront retail, and distribution of commercial cannabis products under State and local law and improve an existing commercial building. The site is currently developed with an existing multi-tenant building. The Project will include only minor interior improvements and no changes beyond existing use proposed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building with no proposal for exterior changes or the addition of square footage. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
