Replace approximately 325' of degraded 2" galvanized iron waterline with 6" PVC waterline. All waterline is located within a paved public street right of way. Replacement is necessary due to degradation and leaks. The pipe is only being upsized to meet minimum standards and fire flows and will not provide more capacity.
