The project is located on State Route 184 at the intersection of Kern Canyon Road and Morning Drive at post mile 9.656 in Kern County.

The project would enhance State Route 184 to meet Caltrans standards. Work would include:

- Install 4' thick AC pavement.
- Adjust utility lids.
- Add gutter, curb, and sidewalk along Kern Canyon Road (State Route 184).
- Conduct striping.
- Install commercial signage.
- Construct a commercial driveway into the shopping center.
