The California Department of Transportation (Caltrans) initiated a Director's Order to repair a failed dual barrel corrugated metal pipe (CMP) culvert located on State Route 49 at post mile (PM) 17.76 in Nevada County. Caltrans proposes mobilization, remove CMP dual barrel culvert and replace with reinforced concrete pipe (RCP) dual barrel culvert, remove inlet headwall, place rock slope protection (RSP), install a water diversion system, shoring, traffic control, and incidental work.
