Project Location: The Project is located at 124 S J St., Lompoc, CA 93436 in Santa Barbara County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 7/17/2025, by Thomas Sheridan. Northstar Lompoc LLC applied for a Storefront Retail License in an existing facility.

Project Activities:

The Proposed Project will operate a Storefront Retail license within an existing building at 124 S J St., Lompoc, CA 93436 (APN 091-103-018). The Project will utilize an existing 5,227 square-foot building to be used as a cannabis dispensary. Building modifications are minimal and no changes beyond existing use are proposed. Utilities such as electricity and water will be provided by the City of Lompoc.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building with no proposal for exterior changes or the addition of square footage. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
