The California Department of Transportation (Caltrans) initiated a Director's Order to remove and replace a corrugated metal pipe (CMP) culvert located on State Route 174 at post mile (PM) 9.50 in Nevada County. Caltrans proposes mobilization, roadway excavation, remove CMP culvert and replace with reinforced concrete pipe (RCP) culvert, backfill, place hot mix asphalt (HMA), ditch repairs, install new drainage inlet, traffic control, and incidental work.


