Project Location: The Project is located at 2548 ALBATROSS WAY, SACRAMENTO, CA 95815, in Sacramento County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Retail Non-Storefront License submitted on 10/16/2025, by Johnny Chung.

Project Activities:

The proposed project will operate a retail non-storefront license out of an existing facility located at 2548 Albatross WAYS, Sacramento, CA 95815 (APN 266-0381-017). The two buildings on the property total 17,450 sq ft, on 0.41 acres. The property is flat, provides a paved parking lot, hosts multiple ornamental trees, rolling doors, flat roof and surrounded by a chain link fence. The neighborhood is zoned for industrial warehouse and storage. The property is north of El Camino Avenue and east of Highway 80. The warehouse was built in 1971 and renovated in 2017.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
