The California Department of Transportation (Caltrans) initiated a Director’s Order for an emergency project to repair a soundwall that was hit by a commercial vehicle at Post Mile (PM) 28.4 on State Route 99 in Sutter County. Caltrans proposes mobilization, repair soundwall as required (approximately 100 feet), traffic control, and incidental work.
