The project proposes to merge 4 existing parcels into 2 and construct a one-story, 10,100 square foot Behavioral Health Center (BHC) on County-owned property. The BHC would provide a range of behavioral health services to low-to-moderate income individuals and families in the area, providing facility space for individual counseling offices, and meeting rooms for group therapy and staff training. The project would also renovate the existing parking areas on the west and south side.

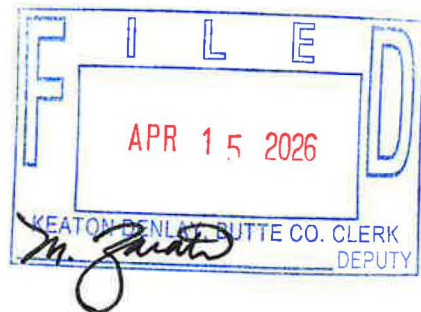
