The California Department of Transportation (Caltrans) initiated a Director’s Order to repair sinkholes located on State Route 193 at post mile (PM) 2.00 and PM 25.85 in El Dorado County. Caltrans proposes mobilization, remove failed corrugated metal pipe (CMP) culverts and replace with new reinforced concrete pipe (RCP) culverts, soil excavation, backfill, install headwall, rock slope protection (RSP), drainage inlet (DI), traffic control, and incidental work.


