Project Activities: The Project will operate a cannabis distribution license out of an existing facility located at 5113 COMMERCIAL WAY, UNIT# 5 HATHAWAY PINES, CA 95233 (APN 030-010-053-000). Business will occur on a 6.67-acre lot zoned M4 (Business Park) in Hathaway Pines.
