Description of Nature, Purpose, and Beneficiaries of Project: The Board of Trustees ("Board") for the Moraga School District ("District") proposes to modernize and repair facilities at the Joaquin Moraga Intermedia School campus ("Campus"), located on a District-owned site Moraga, California. The project consists of select building modernization including: reroofing of 3 buildings, roof repair of 5 buildings, upgrading fire alarms campus wide, select window replacement, switchgear upgrade, and select deferred maintenance on 1 building. Site scope consists of regrade and reseed of the baseball field, decorative entry fencing, access control gates, repair of perimeter running track, regrade, repave and reseed of select grass areas, and revitalization of 2 quads.

Reasons why project is exempt: On December 9, 2025, the Board approved Lease Lease-Back agreements between the District and CORE Construction, Inc. for construction services related to the Joaquin Moraga Middle School and Donald Rheem Elementary School Modernization Projects ("Project"). The Project is exempt from the California Environmental Quality Act (CEQA) pursuant to Title 14 of the California Code of Regulations, sections 15301 (Class 1 - minor alteration of existing structures), sections 15302 (Class 2 - replacement or reconstruction), 15303 (Class 3 - new construction of small structures), and 15314 (Class 14 - minor additions to schools). The Project involves replacement or minor expansion of existing school facilities and does not increase capacity beyond regulatory thresholds. It does not trigger any exceptions to categorical exemptions under CEQA Guidelines section 15300.2, as the Project is not located in a particularly sensitive environment and will not have cumulative impacts resulting from successive projects of the same type, there are no unusual circumstances associated with the Project, no impact on scenic highways, no location on a hazardous waste site, and no substantial adverse effect on historical resources.
