Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Manufacturing License submitted on 8/23/2025, by LUCKY 13 VENTURES LOS ANGELES LLC.

Project Activities:

The proposed project will operate a non-storefront retail, distribution, and manufacturing license out of an existing facility located at 2827 NORTON AVE, LYNWOOD, CA 90262 (APN 6170-015-030). The applicant will store cannabis products for non-storefront retail, distribution and manufacturing on a 1.08-acre lot. Southern California Edison will provide power and the City of Lynwood will provide water.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 Categorical Exemptions consist of being consistent with the City's General Plan and Zoning Code, located within the city limits, project is no more than five acres, substantially surrounded by urban uses, no value as habitat for endangered, rare, or threatened species, no result in any significant effects relating to traffic, noise, air quality, or water quality, and is adequately served by all public utilities. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
