The City of San Dimas plans to capture, treat, and infiltrate stormwater runoff from San Dimas and Glendora, improving water quality in the Gladstone Street Storm Drain (BI 1121) and San Dimas Wash. The Project will enhance park infrastructure with features like a stormwater infiltration system, inclusive playground, demonstration garden, and permeable paving in the new parking lot, focusing on sustainability and cost-effective solutions in collaboration with the City to meet community needs.
