The proposed Project requires the approval of a General Plan Amendment, Zone Change, Tentative Tract Map, Development Review, and a Conditional Use Permit (Case No. PL2025-29) to allow for the redevelopment of the approximately 3.9-acre site with a for-sale residential community of 49 units in a mix of detached and attached three-story condominiums, together with private drives, parking, landscaping, and utilities. A total of 120 automobile parking spaces would be provided.
