The California Department of Transportation (Caltrans) initiated a Director's Order to remove and replace two failed corrugated metal pipe (CMP) culverts located on State Route 84 at post mile (PM) 0.00 and PM 1.5 in Yolo County. Caltrans proposes mobilization, roadway excavation, remove failed CMP culverts and replace with new reinforced concrete pipe (RCP) culverts, backfill, place hot mix asphalt (HMA), traffic control, and incidental work.
