Project Title: Golden Dreamers, LLC (Project)

Project Location: The Project is located at APN 019-350-034-000 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Outdoor commercial cannabis license.

Project Activities: The proposed project includes the cultivation of up to 10,000 sf of outdoor mature canopy located in Trinity County (APN 019-350-034-000). The parcel is approximately 3.3 acres in size and the parcels immediately surrounding are zoned as Unclassified. Cultivation activities include approximately 9,840 sf of mature canopy in four metal greenhouses. Water will be permitted by an existing permitted well and a 5,000-gallon water storage tank. There is a permitted onsite septic system that serves wastewater needs. The site is currently developed with a single-family residence. Access to the site is provided via Fir Meadow Court, an existing short dirt road, which connects to Trinity Pines Drive, a paved county-maintained road.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
