Key projects include replacing outdated classroom buildings with a new three-story, 30,000-square-foot building, adding an 8,500-square-foot weight and PE facility, upgrading stadium bleachers and support spaces, and renovating select existing buildings. Campus-wide improvements emphasize sustainability and infrastructure upgrades, with additional future projects identified for the library, science classrooms, athletic fields, pedestrian
