Amendment Application to allow rezone of an existing 15.02-acre parcel currently zoned AL-20 (Limited Agricultural, 20-acre minimum parcel size) and C-4 (Central Trading). The project proposes to rezone the AL-20 portion of the project site to the R-1-B(c) (Single-Family Residential, 12,500 square-foot minimum parcel size, Conditional) Zone District with shared use of an existing well subject to conditions restricting further sub-division unless/until community water is available, and the C-4 Zone District to remain. If this rezone is approved, the Applicant intends to subdivide the parcel into three (3) 2-acre parcels and a remainder. The remainder parcel would be comprised of land zoned C-4 and R-1-B(c).
9. **Surrounding land uses and setting: Briefly describe the project's surroundings:**
The surrounding parcels are designated Agricultural and utilized for various commercial and residential uses.
10. **Other public agencies whose approval is required (e.g., permits, financing approval, or participation agreement.)**

The project was routed to the Dumna Wo Wah Tribal Government, Santa Rosa Rancheria Tachi Yokut Tribe, Picayune Rancheria of the Chukchansi Indians, and Table Mountain Rancheria in accordance with Public Resources Code Section 21080.3.1(b). No tribe expressed any concerns related to Tribal Cultural Resources (TCRs). With adherence to the mitigation measures noted in Section V. Cultural Resources of the Initial Study document, the project will have less than significant impact on tribal cultural resources as defined in Public Resources Code Section 21074.
