Project Title: Wireless Right-of-Way Permit No. 25-010, Coastal Development Permit Exemption No. 26-032, and Categorical Exemption No. 25-098

Project Location – Specific: 29469.5 Bluewater Road, within the public right-of-way

Description of Nature, Purpose, and Beneficiaries of Project: An application to modify an existing T-Mobile wireless facility on a Southern California Edison utility pole in the public right-of-way near the 29400 block of Bluewater Road. The project would remove one antenna, one equipment shroud, two radio units, a fuse, and the existing strand-mounted antenna kit, and would install one new strand-mounted antenna (approximately 14.5 inches in diameter) mounted on a new antenna kit, along with one equipment shroud enclosing pole-mounted radio equipment, one fuse, two RF caution signs, replacement coaxial cables, and associated equipment. The existing 39-foot, 4-inch wood utility pole (SCE Pole ID No. 770774E) will remain in place with no change in height or dimensions. No excavation, trenching, or new ground-mounted equipment is proposed. All improvements would occur on the existing pole. In addition to City-issued permits, the applicant is required to obtain permits for use of the pole by Southern California Edison and an encroachment permit from the City Public Works Department.
