Description of Nature, Purpose, and Beneficiaries of Project The proposed project would involve the replacement of existing roofing systems and maintenance repairs to various buildings at Seaport Village by San Diego Unified Port District (Applicant) in the city of San Diego, California. Work to specifically complete the proposed project would include the selective removal and replacement of existing roofing systems and various associated capital improvements, including, but not limited to, the selective removal and replacement of deteriorated roofing material, as well as upgrades to flashing, penetrations, edge metal, membranes, and permanent leak repairs. Construction of the proposed project is anticipated to occur in Spring 2026 and would take approximately three (3) months to complete, with ongoing maintenance as needed.

Due to its nature and limited scope, construction of the proposed project would generate a minor amount of vehicle trips and would require limited use of equipment. Therefore, impacts related to air quality, greenhouse gas emissions, and transportation and traffic are not anticipated to occur. Furthermore, the Applicant would be responsible for complying with all applicable federal, state, and local laws regarding construction demolition debris, hazards and hazardous materials, and stormwater.
