The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Retail License submitted on 11/12/2025 by Belal Rahman.

Project Activities:

The Project will consist of a cannabis retail store located at 1958 West Florida Avenue, Hemet, CA 92545. The APN is 448-440-024. It will operate out of an existing 5000 SF building on a lot area of 20,037 SF. Cannabis activities will occupy 1606 SF within the building. There will be no other cannabis activities on site.
