Project Location: The Project is located at 73980 DOBIE LN COVELO, CA 95428 (APN 034-270-53-00).

County: Mendocino

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a Small Outdoor commercial cannabis license submitted on 12/3/2025 by Joanna Wolf.

Project Activities: The Project will consist of cannabis cultivation on an existing site located at 73980 DOBIE LN COVELO, CA 95428 (APN 034-270-53-00). This project has been issued Mendocino County cultivation permit CAN-C-2023-3003. The site is zoned Agricultural (AG:160) and was previously used for cattle grazing. This site now includes cannabis production with no plans for future expansion. Activities that take place include cannabis cultivation, drying, curing, weighing, trimming, disposal, and storage. The project would continue to source water from an onsite well, there is onsite septic for wastewater, and power is provided by PG&E.
