Project Activities: The Project will consist of a cannabis nursery that will exist inside an existing cannabis cultivation and manufacturing facility. The facility is 34,904 sq ft warehouse on a 2.09-acre parcel in the light industrial and solid waste restricted overlay (M1-S-DWR) zone. The total immature canopy is estimated to be 916 sq ft
