Project Location: The Project is located at 78000 W MOODY RD & 78050 W MOODY RD PIERCY, CA 95587 (APN 052-010-12-00 & 052-020-13-00).

County: Mendocino

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license submitted on 4/6/2025 by BTM FARMS, LLC.

Project Activities: The Project will consist of cannabis cultivation on an existing site located at 78000 W MOODY RD & 78050 W MOODY RD PIERCY, CA 95587 (APN 052-010-12-00 & 052-020-13-00). This project has been issued Mendocino County cultivation permit AG-2018-0422. The site is zoned Rangeland (RL) and was previously used for cattle grazing. This site now includes cannabis production with no plans for future expansion. Activities that take place include cannabis cultivation, drying, curing, weighing, trimming, disposal, and storage. The project would continue to source water from an irrigation pond with a water diversion from a tributary to Parker Creek as a backup water source. There is onsite septic for wastewater and power is provided by PG&E.
