Project Title: Spork Timber Harvesting Plan 4-25-00168-CAL (Streambed Alteration Agreement EPIMS Notification No. EPIMS-CAL-64784-R2)

Project Location: The projects are located within the boundaries of a timber harvesting plan in Calaveras County, within CALWATER watersheds Fine Gold Mine, Headwaters Middle Fork Mokelumne, Schaad's Reservoir, Swamp Creek, and Upper Licking Fork and their connecting tributaries; Township 6N, Range 14E, Sections 13, 14, 22, 23, & 25 and Township 6N, Range 15E, Sections 17, 19, & 30 Geological Survey (USGS) Quad Maps Devil's Nose, Dorrington, Fort Mountain, and Garnet Hill; Mount Diablo Base and Meridian.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification Number EPIMS-CAL-64784-R2, pursuant to section 1611 of the Fish and Game Code to the project Applicant, Sierra Pacific Industries.

The projects are limited to the use and maintenance of seven water drafting sites, construction of permanent rocked fords, and installation of temporary vented fords. All crossing sites are existing stream crossings. Further explanation of work can be referenced within the THP 4-25-00168-CAL.

This is to advise that CDFW, acting as a Responsible Agency, executed the above Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the timber harvesting plan prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.

- 6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
