Project Description (Proposed actions, location, and/or consequences).

A Tentative Parcel Map that would allow the subdivision of an approximately 39.72-acre parcel into four (4) parcels as follows: 10.1 acres (Parcel 1/ RL-10), 10.0 acres (Parcel 2/ RL-10), 10.1 acres (Parcel 3/ RL-10), and 9.06 acres (Parcel 4/ RL-10 & CC). The proposed project does not consist of any physical construction on the existing project site, and thus this Initial Study is not required to evaluate the physical environmental effects of construction of new facilities. Rather, this Initial Study evaluates the reasonably foreseeable consequences of the parcel map, in particular, any uses that would be allowed "by-right" without further environmental review. These net new by-right uses could consist of residential units and agricultural structures, such as barns. The project site would be served by private on-site wells and septic systems. Electric service would be provided through Pacific Gas & Electric facilities.

Identify the project's significant or potentially significant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

The project may have significant impact on oak resources, special-status rare plants, nesting birds, bats, aquatic resources, and cultural/tribal cultural resources. Mitigation for oak resources includes adherence to the County's Oak Resources Management Plan and engaging in the following activities: paying in-lieu fees, replacement planting, conservation, etc. Mitigation measures for rare plants, nesting birds, and bats involve pre-construction surveys, fencing, and monitoring if the special-status species are present. Aquatic resources require wetlands delineations and the applicable state and federal permits. Cultural/tribal cultural resources require coordination with the County and appropriate tribes and adherence to state laws in the event of discovery.
