This is to advise that the County of San Diego General Services has approved the above-described project on April 8, 2026, and found the project to be exempt from the CEQA under the following criteria:

Statement of reasons why project is exempt:

This major maintenance project is categorically exempt from CEQA pursuant to Section 15301, Existing Facilities as it involves replacing two existing gates at the sally port of an existing detention and re-entry facility that involves no expansion of the existing use of the facility. Further, no exceptions listed in CEQA Guidelines Section 15300.2 apply to the project. The project will not impact environmental resources of hazardous or critical concern that are designated, precisely mapped and officially adopted by government agencies; does not contribute to cumulative environmental impact; will not have a significant impact on the environment due to unusual circumstances; does not damage scenic resources within a designated state scenic highway; and is not on the list of Hazardous Waste and Substance Sites pursuant to Section 65962.5 of the Government Code.
