Allow a one-time special event (outdoor concert) in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District. The special event setup is scheduled from May 11th to May 14th with the concert taking place on Friday May 15, 2026, between the hours of 2:00 PM and 11:00 PM. The dismantling of the event will occur from May 16th to May 22nd.
- 9. Surrounding land uses and setting: Briefly describe the project's surroundings:**
The subject parcels are located in an agricultural area characterized by sparse residential development and large parcel sizes.

Under the provisions of Assembly Bill (AB) 52, the County was required to provide notice of preparation of this Initial Study to Native American tribes who had previously indicated interest in reviewing CEQA projects. Notices were sent on February 27, 2026 to the appropriate Tribal government representatives. One of the tribes, the Table Mountain Rancheria expressed interest in this project and requested a California Historic Information System records search be undertaken and that the results of the search be provided to the Tribe once available, which request was initiated by the County on April 1, 2026.
