The California Department of Transportation (Caltrans) initiated a Director’s Order for an emergency project to repair bridge components at the Fort Sutter Viaduct (24-0188R) at Post Mile (PM) 0.241 on State Route 51 in Sacramento County. Caltrans proposes site preparation, clean joint openings, repair hinge diaphragms and girders, traffic control, and incidental work.

Purpose and Need

The purpose of this project is to repair damaged components of the Fort Sutter Viaduct.

This project is needed to restore the structural integrity and load-carrying capacity of the bridge and to prevent spalling concrete from falling onto the parking area under the bridge.
