The California Department of Transportation (Caltrans) initiated a Director's Order to make drainage repairs on Interstate 80 at post miles (PMs) R9.83, R10.75 and R10.84 in Nevada County. Caltrans proposes mobilization, repair/replace culverts, repair relay entrance tapers, import borrow material, place rock slope protection (RSP), slurry backfill, place concrete curb, and incidental work.
